## Highlights: The year in review

In 2011, AustLII launched its first app for iPhones and iPads and due to popular demand commenced development work to enable apps to be used on other mobile platforms. In the six months post the launch of the app, over 233,000 accesses to AustLII have been through the app.

AustLII added many new databases to its free-access online public library bringing the total to 485 databases. Two major subject libraries were added - the health practitioner law library and the aviation law library.

International development resulted in two new Legal Information Institutes in India: [www.liiofindia.org](http://www.liiofindia.org) and in Liberia: [www.liberlii.org](http://www.liberlii.org).

## Did you know these search tips?

1. If you know the title of the case or document you are looking for, use title (your search term) in the search box to reduce your search results. For example: title (mabo).

2. You will find legislation that has never been amended in the Numbered legislation databases and not in the Consolidated legislation databases.

3. To repeat your AustLII search on "Law on Google" use the "Repeat Search Over" functionality on AustLII, it appears to the right of the search box.

## Point-in time legislation

*Ever need to compare one piece of legislation at different points in time for amendments?*

AustLII has been experimenting with point-in time legislation. It is currently available in NSW and SA. Just go to the relevant jurisdiction page.

Under NSW legislation you will see:

**New South Wales Acts (Point-in-Time)** and under SA legislation you will see **South Australian Acts (Point-in-Time)**.

Please find an example below from the *Road Transport (General) Act 1999* (NSW). You will see that in the 2004 version the blue words have been added and the red words (which existed in the 2000 version) have been removed.

### ROAD TRANSPORT (GENERAL) ACT 1999

## Cases and legislation: Quick search tips

*Tips from Annelies:*

At a couple of recent presentations I gave to barristers, I provided some tips on quickly searching for cases and legislation on AustLII.

With the vast quantities of data on AustLII, knowing these shortcuts can save you time, hence I thought I would share these tips with our News readers.

### Legislation: Quick search tips

If you know the name of the legislation and the specific section you want to find, rather than browsing the jurisdiction and legislation pages, just enter the name of the Act and the section number in the search box in any of the following ways, for example:

- Corporations Act 2001 s 111AR
- Family Law Act 1975 section 12B
- Income Tax Assessment Act s. 98

### Cases: Quick search tips

If you know the name of the parties in a case you are looking for, just enter the name of the parties with a v in the middle. For example:

- Hogan v Hinch
- Luxottica Retail v Specsavers
- Pascoe v Police

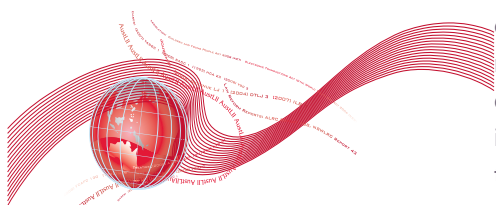
more presentations and short seminars have been provided to our users, donors and stakeholders.
